ACKNOWLEDGEMENT, RELEASE, COVENANT AND INDEMNIFICATION AGREEMENTS

Since its acquisition by Honduras Outreach, Inc., thousands of visitors from the United States have enjoyed rewarding visits to Rancho el Paraiso and other locations in Honduras. Because the ranch is a working farm in a relatively inaccessible, economically poor area of central Honduras, it is very important that visitors be in good health and understand in advance the conditions at and near the ranch and the travel required to get to the ranch and to villages and other places they may visit. In exchange for the opportunity to visit the ranch and/or to participate in Honduras Outreach activities, visitors and parents of minor youths who visit are required by Honduras Outreach to enter into this Agreement. It is a covenant not to sue Honduras Outreach or its personnel and to release and indemnify them against certain types of claims. You should carefully read and be sure you understand the following information and agreements.

Ranch Location and Travel Conditions; Medical Considerations

Honduras is one to the most abjectly poor countries in the western hemisphere. Rancho el Paraiso is located in rural, central Honduras many miles from the nearest telephone landline or paved road. The visit to the ranch will involve travel on domestic and international air carriers, as well as buses and other vehicles, some of which vehicles may not have seat belts. Vehicle maintenance in Honduras is often inferior to that in North America, only some of the roads are paved, virtually none of the roads are in good repair, and the roads and public areas are not well patrolled by public safety officers. As is true in most of the world, crimes against property and people occur with some frequency in the areas of Honduras that will be visited, and there is some risk of theft, kidnapping, terrorism and other violent crimes. Routine communications with the ranch are not possible, and emergency communications are unreliable. Food borne illnesses are common, and municipal system water is not safe to drink. Medical services, particularly emergency services, consistent with North American standards are *not* available, and the nearest hospital is located several hour's drive from the ranch.

The ranch is operated, and Honduras Outreach activities are conducted, in an effort to assure the health and safety of both visitors and the Hondurans who live and work there. However, the ranch is a working farm with the inherently dangerous conditions requiring care on the part of visitors associated with any farm, including the presence of farm equipment and horses, cattle and other large animals. Visitors who work on the ranch or in a village may engage in hazardous manual labor using picks, shovels, machetes, saws, knives, trowels, hammers, ladders, power tools and other potentially dangerous tools, may work at heights greater than ten feet above the ground and may be subjected to inclement weather, including weather contributing to a risk of heat exhaustion. The risks and hazards associated with travel and other activities in Honduras include possible bodily injury and death, and this is not a complete list of the risks and hazards that may be encountered.

Visitors must share responsibility for protecting their own health and safety by taking appropriate precautions before and during their trip, observing common sense and Honduras Outreach safety rules, undertaking only activities, and using only tools, with which they are comfortable and following the advice and directions of Honduras Outreach staff members throughout their visit to Honduras. You should consult with your personal physician before your trip Honduras and obtain all appropriate vaccinations and protective medicines. You should have a physical if you have not recently had one, and you must supply Honduras Outreach with a physician's statement indicating that your doctor is not aware of any health condition or other reason you should not participant in the trip and activities.

RELEASE AND COVENANT AGREEMENT

In consideration of the opportunity afforded me by Honduras Outreach, Inc. to visit Rancho el Paraiso and/or engage in Honduras Outreach activities, and in recognition of the possible hazards to which I may voluntarily subject myself on the ranch and elsewhere in Honduras and in traveling outside the United States of America to visit a substantially less developed region of the world, I acknowledge that I have read and understand the information and dangers set forth above, I assume all risks associated with these activities and travel, and I hereby knowingly, freely and voluntarily waive any right, claim or cause of action, of any kind whatsoever, arising as a result of my visit to Honduras, including travel relating to the visit, from which any liability may or could accrue to Honduras Outreach, Inc., its officers, directors or employees (collectively, the "Releasees"), and I hereby release the Releasees from any such claim or causes of action I may in the future have against any of them arising out of such activities, and I hereby covenant not to sue or otherwise assert claims of any kind against any of the Releasees arising out of such activities. This Agreement shall be binding on me and my heirs, executors, legal representatives and assigns, and shall be governed by the internal laws of the State of Georgia, and any litigation between me and the Releasees pertaining to any of these matters shall be brought and conducted solely in the Superior Court of Dekalb County, Georgia.

Indemnification, Release and Covenant by Parents or Guardian of Minor Visitor

Both parents or legal guardians of each visitor to the ranch who is under 18 years of age should read carefully and must sign the following Covenant Not to Sue, Release and Indemnification.

INDEMNIFICATION, RELEASE AND COVENANT AGREEMENT

I/We, the parent(s) or guardian(s) of the minor identified above (the "Minor"), in consideration of his or her being permitted to visit Rancho el Paraiso, and/or engage in Honduras Outreach activities, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, acknowledge that I / we have read and understand the dangers identified above and the information set forth above about Rancho el Paraiso, Honduras and activities in Honduras, and I / we hereby agree: (1) to indemnify and hold forever harmless Honduras Outreach, Inc., its officers, directors and employees (collectively, the "Releasees") against loss from any and all claims, demands or actions in law or in equity that may hereafter at any time be made or brought by the above-identified minor or by anyone on behalf of him or her for the purpose of enforcing a claim arising out of or in connection with the visit or associated activities or travel and (2) to waive and release the Releasees from, and covenant not to sue any of the Releasees asserting, any claim, right or cause of action of any kind whatsoever, arising as a result of the visit or associated activities or travel by the Minor, which I/we may ever have. This Agreement shall be binding on me/us and my/our heirs, executors, legal representatives and assigns and shall be governed by the internal laws of the State of Georgia, and any litigation between me/us and the Releasees pertaining to any of these matters shall be brought and conducted solely in the Superior Court of Dekalb County, Georgia.
